169 – 7th Annual Shawane Dagosiwin: Indigenous Knowledges: <u>Visioning for Inclusive and Sustainable Relationships in Research and Educational Practice</u>

Trustee Hildahl informed trustees that she attended the 7<sup>th</sup> Annual Shawane Dagosiwin: Indigenous Knowledges: Visioning for Inclusive and Sustainable Relationships in Research and Educational Practice. Trustee Hildahl informed the trustees that one of the workshops she attended was an Update on Work-in-Progress – Examining the Development of an Aboriginal School System in Winnipeg. The Aboriginal Council of Winnipeg is arranging an Aboriginal School System Steering Committee.
