### 70 – Coronary Health Improvement Project (CHIP) Program

Trustee Babinsky informed trustees that he has attended some of the free sessions offered by the Coronary Health Improvement Project (CHIP) and encouraged trustees to attend the free information sessions at the Health and Wellness Centre, Seven Oaks Hospital. Dr. Rex Sokolies has in the past appeared as a delegation to the Board to discuss health issues which are addressed at the CHIP Program free information sessions.

## 71 - Trustee Babinsky's Trip to Cairo, Egypt

Trustee Babinsky informed trustees that he will be leaving for a trip to Cairo, Egypt on January 11, 2011, and that he will be visiting schools while there.
