#### 120 – Honour Band & Choir

Trustee Sneesby informed trustees that she was able to attend the Honour Band/Choir which had two guest conductors; Frances Farrell and Dr. Wendy McCallum. Both conductors did an extraordinary job in working with the students for three days to put on the concert. Trustee Sneesby informed trustees that she would like to congratulate the students and guest conductors, as well as the music consultant, Trish Penner, for producing such a wonderful event.

# <u>121 – Sisler Calculus Courses</u>

Trustee Sneesby informed trustees that Sisler High School was acclaimed one of the ten best public schools in Canada and the best all-around high school by Maclean's Magazine. Sisler remains the only high school in Manitoba that challenges both University of Manitoba Calculus I and II courses. Twenty students challenged both courses this year and they obtained an A+ class average in Calculus I and an A class average in Calculus II. Over 100 students from Sisler wrote the University of Waterloo Math Contests with fifteen students receiving Certificates of Distinction, as well, Sisler High School's Grade 9 team placed 2<sup>nd</sup> in our zone in the Pascal Contest. Trustee Sneesby informed trustees that she would like to extend a big congratulation to the staff and students at Sisler High School for doing such a great job.
