<u> 150 – Trustee Apology</u>

Trustee Wasyliw requested an opportunity to address an issue regarding an interview by a Free Press reporter in relation to an incident in the River Heights community. During the course of that interview, Trustee Wasyliw used an illustration and named St. John's High School in that interview. Trustee Wasyliw informed trustees that his comments were insensitive and ill advised and he realized that he was playing into certain stereotypes and he deeply regrets making them. He apologized to the people in the gallery and to his fellow collegues.

Trustee Bautista informed trustees that she wanted to thank Trustee Wasyliw for his remarks. As a former graduate of St. John's, she takes great pride in the school and community. Trustee Baustista suggested that the next step is to get past this incident and to unite for the students in the school and communities of the Winnipeg School Division. Trustee Bautista invited Trustee Wayliw to a barbeque proposed at St. John's High School as part of the healing process.

151 – Manitoba School Boards Association Annual Convention

Trustee Hrynyk informed trustees that she had the pleasure of attending the Manitoba School Boards Association Annual Convention on Friday with Trustees Hildahl, Bautista and Collins. Trustee Hrynyk advised trustees that she attended an excellent presentation hosted by Apprenticeship Manitoba. The presentation included not only teachers working in the apprenticeship program but a student who was a very good student academically but was very interested in welding. It was unfortunate that she was apparently discouraged to go into welding and was encouraged to go into the academic stream of studies. She has since received her level one apprenticeship as a welder and is now a red seal welder. Trustee Hrynyk informed trustees that she wanted to stress that the Division utilize Apprenticeship Manitoba in our high schools. In response to Trustee Hrynyk's comments, the Chief Superintendent informed trustees that the Division has hired a support staff member for apprenticeship programs and he along with senior administration have been in discussion and collaborating with Apprenticeship Manitoba.
