Trustee Hildahl wished to congratulate the students, teachers, parents and members of the community who have been working together to encourage and enhance the achievement of Division students.

208 – Manitoba Education Research Network Awards

Trustee Hildahl informed trustees that she attended the Manitoba Education Research Network (MERN) 2011 Awards luncheon at the Manitoba Legislative Building and was delighted to learn that the Director of Research, Planning and Systems Management, Doug Edmond, was one of the recipients of the Research Achievement Award.

Trustee Hildahl informed trustees that MERN works to improve the quality of education in Manitoba's schools by establishing partnerships for research studies, collecting and analyzing data and supporting other forms of research activities. Trustee Hildahl commended Mr. Edmond on his achievements.

212 - Robert H. Smith Search and Rescue

Orange parachutes bloomed in the skies over south Winnipeg on the afternoon of June 9, 2011, as two Search and Rescue Technicians (SAR Techs) from 435 Transport and Rescue Squadron (Sqn) based at 17 Wing, floated down from a CC-130 Hercules to perfect landings in front of more than 200 cheering students at the River Heights Community Centre.
