SUPERINTENDENT'S REPORT No. 1-2013

- In accordance with Policy AGAB-Recognition for Special Accomplishment authority was given for:
- Twelve students from Sargent Park School will each receive funding in the amount of \$400 (total \$4,800) to support their attendance in the Human Rights and Holocaust Studies Program in Washington DC, from May 5 to May 8, 2013. Funding for substitute costs for two teachers for up to two days (total 4 days) was approved.
- Ten students from Tec Voc High School will each receive funding in the amount of \$400 (total \$4,000) to support their attendance in the Human Rights and Holocaust Studies Program in Washington, DC from April 21 to April 24, 2013. Funding for substitute costs for two teachers for up to two days (total 4 days) was approved.
- Fifteen students from Cecil Rhodes School will each receive funding in the amount of \$400 (total \$6,000) to support their attendance in the Human Rights and Holocaust Studies Program in Washington, DC from May 12 to May 15, 2013. Funding for substitute

- costs for three teachers for up to two days (total 6 days) was approved.
- Fifteen students from Elmwood High School will each receive funding in the amount of \$400 (total \$6,000) to support their attendance in the Human Rights and Holocaust Studies Program in Washington, DC from May 12 to May 15, 2013. Funding for substitute costs for three teachers for up to two days (total 6 days) was approved.
- Six students from École secondaire Kelvin High School will each receive funding in the amount of \$400 (total \$2,400) to support their attendance in the Human Rights and Holocaust Studies Program in Washington, DC from April 21 to April 24, 2013. Funding for substitute costs for one teacher for up to three days (total 3 day) was approved.
- Sixteen students from Isaac Newton School will each receive funding in the amount of \$400 (total \$6,400) to support their attendance in the Human Rights and Holocaust Studies Program in Washington, DC from April 21 to April 24, 2013. Funding for substitute costs for three teachers for up to three days (total 9 days) was approved.

- Stanley Knowles School will receive funding for substitute costs for one teacher for one day (total 1 day) for one Stanley Knowles staff member's attendance in the Human Rights and Holocaust Studies Program in Washington, DC from May 11 to May 14, 2013.
- Approximately 46 Inner City students from five schools, General Wolfe, Gordon Bell, Hugh John Macdonald, R.B. Russell and Children of the Earth High School will receive funding in the amount of up to \$15,000 to support their attendance at the Human Rights and Holocaust Studies program held May 11 to May 14, 2013 in Washington, DC. Funding for substitute costs for ten teachers for one day (total 10 days) was approved.
