NEW BUSINESS

- 1. The motion was passed that that
- a) Population of ward boundaries and representation quotient be reviewed as a result of the November 2014 election to determine that it met the requirements outlined in the Public Schools Act.
- b) Administration develop projections for the northwest corner of the division to ensure that population of ward boundaries and representation quotient will be met for the 2018 election.
- 2. The motion was passed that
- a) Administration develop a division-wide Arts Education Strategy with the goals of expanding arts education in the Winnipeg School Division. The strategy will focus on providing access to

all students with high quality, diverse arts education with resources distributed on an equitable basis. In developing this strategy the administration will consult broadly with staff, students, parents, outside arts organizations and the Winnipeg School Division community.

- b) A draft of the strategy be referred to the Policy/Program Committee for review and recommendations.
- 3. The motion was passed that
- a) Administration create an annual survey of inividual WSD schools' arts programming including what specialized teachers are employed, in what disciplines, what outside arts partnerships the schools engage in, what type of clubs and performance opportunities both as participants and as audience members do the students have at each school. In addition, to track the average time per week that students receive in arts programming per school.
- b) A draft of the survey is to be referred to the Policy/Program Committee for review and recommendations.
- c) The completed survey to be administered yearly and that a report be provided to the Board of Trustees on a yearly basis outlining the state of arts education in the Winnipeg School Division.
- 4. The motion was passed that the Board approve in principle the partnership with RINK Hockey Academy and Kelvin High School.
